- 5. All the applications received in response to the advertisement will be scrutinized / shortlisted by a Screening Committee (comprising members as prescribed by ICMR).
- 6. Thereafter, a Selection Committee (comprising members as prescribed by ICMR) will hold interviews of the shortlisted applicants.
- 7. Pay: (Rs.56,000/-+HRA) per month for Research Scientist (Medical).
- 8. Vacancy: 01 (One) [Research Scientist (Medical/Non-Medical) —01]
- 9. Please note that Candidates must attach photo and submit all necessary documents pertaining to academic credentials, achievements, distinctions, service experience etc;
- 10. Age: Not less than 25 years and not more than 40 years on 01.01.2025 (as per ICMR guidelines).
  - The upper age limit may be relaxed for the candidates belonging to SC, ST, & other Backward Classes as per Government Rules or Orders issued from time to time.
- 11. In case, any of the statement made in the application be subsequently found to be false within the knowledge of the candidates- his/her candidature shall be liable to cancellation, and even if appointed to a post on the results of this examination his/her appointment shall be liable to be terminated. Willful suppression of any material fact shall also be similarly dealt with.
